Application Procedures

1. Registration not include the application for relevant travel documents or visa if necessary. (From the date of departure, travel documents should be valid for not less than six months)
2. 50% of full amount should be payable in respect of registration.
3. Balance payment must be paid in full amount 14 days in prior to departure date. Overdue payment will be regarded as cancel case which is non-refundable and should not be transferred to another uses or transferred to other departure dates. If you have any enquiry, please call 2772-7301

Costs include

1. Hotel: listed on itinerary. Basically two persons share in one bedroom
2. Transportation: use of air-conditioned luxury tour buses and/or listed in the itinerary the various modes of transports.
3. Meal: the table set out in the itinerary : breakfast, lunch and dinner.
4. Program: itinerary of the tour set out in the table shows.
5. Guide: The land reception will arrange a local tour guide.
6. Baggage size: cannot exceed 29 x 20 x 10 inches per person.
7. Hong Kong Travel Industry Council (TIC) 0.15% stamp levy, in order to bring a reliable guarantee for the customers:
 - For inquiries about the levy coverage, please call the Travel Industry Compensation Fund Management Board Secretariat, Hotline :2918-7564. To ensure that the above rights, please upon the tour reservations request an original travel receipts with TIC stamp.

Fees do not include

1. All kinds of insurance, travel documents, visas and needle pox paper costs.
2. The airport passenger taxes and all kinds of taxes. (Subject to change without further notice)
3. Beyond our control cases, such as priority workers and traffic delays caused to additional expenditures.
4. Baggage exceeds the specification (size / weight).
5. Personal expenses such as laundry, telephone, telegraph, soft drinks, wines and spirits.
6. Due to personal reasons, traffic, typhoon or other circumstances beyond the control of the Company caused to additional expenditures.
7. Single room difference .

Temporary cancellation and refund

1. Under special circumstances, the Company have the right, before or after departure to cancel or replace any tourism programs or to shorten or extend the journey, in this case, the costs will be proportionally increase or decrease, customers shall not be object to such arrangements.
2. Group tour cannot be cancelled after signing the contract.

Special circumstances and responsibilities

1. Special circumstances beyond the control of the company's, such as war, political unrest, natural disasters, severe weather, workers and the industrial action, etc. The Company have the right to leave before or after departure to cancel or replace any of a tourism project, and have the right to shorten or extend the journey.
2. Group Air tickets must travel with the whole group, any guest requests stay behind, the Company may help to arrange. No matter success or not it should not form any reasons to asking for refund.
3. Group Trip arranged (air-ticket / admission tickets / hotel or tourism project) are bookings in advanced, in any circumstances, shall not be refunded.
4. Please notify to the local Ordinances/ Laws, prohibited to carry contraband goods, guests shall be responsible for any illegal activity made by themselves.
5. The Company arranges transportation (such as aircraft, ships, trains or buses, etc.), accommodation, meals, tourist spots and entertainment items of which such arrangements are not owned, managed or operated by the Company. Any remedies in all kinds in case of traffic delays, baggage loss, accidental deaths, injuries and property losses, the Company shall not be responsible for such claims.
6. Guests shall apply for all travel documents/visas before departure in respect of all countries to be visited. Due to personal reasons, the Company will not responsible for the guests being refused to entrance the visiting countries.
7. The Tour Introduction is printed by the "Easy-Access Travel Ltd" which is unrelated to the airlines, the airlines of the listed in the Tour Introduction is not responsible for the content in the Introduction.
8. The airline is only responsible for the provisions contained in the Air-tickets.

Other details

1. The expenses listed in the Itinerary is based on time being ticket prices, hotel and travel fares, programs and other foreign Currencies. Then in case of change of price to fuel surcharge or foreign currency fluctuations, the Company reserves the right to adjustment costs prior to departure. (All paid up tour will not be affected by the above provisions.)
2. The Company will not accept any cancellation due to travel documents/visas problems.
3. Dues to personal reasons, such as require self depart , individual Return (early leave from the group), the Companies may arrange. But the Company will not be responsible for any traffic delays caused to direct or indirect or loss.
4. All hotels listed in the itinerary, the Company shall depend on actual circumstances to changes to other hotel with the same level..
